

Independent Living Centers



- *Center* Staff and Board Member rosters must have a composite of 51% self-identifying as an person w/a disability.
- Centers help people with disabilities achieve or maintain more self-sufficiency, live more productive lives in their communities.
- **Centers** directly provide or coordinate-through referrals, services which assist Consumers in increasing their abilities to exercise control over their lives.
- **Centers** assist Consumers in exploring alternatives to institutionalization & are encouraged to make their own decisions about how they live.
- *Centers* are **501c3** not-for-profit and most services are free.
- Centers believe everyone has a right to live as independently as they choose and are able.
- **Centers** partner to meet the needs of Consumers without duplicating services of other agencies or organizations.
- **Centers** offer a broad range of community-based, consumer-directed services to people of <u>all ages</u> and disabilities.
- Centers are not residential facilities.

The Vocational Rehabilitation (VR) and Supported Employment (SE) programs are funded, in part, with federal grant funds awarded by the Department of Education. In FFY 2021, the agency received \$64,569,784 in federal grant funding and \$17,475,685 of state funds for VR services. Total VR funding of \$82,045,469 is comprised of 78.7% federal monies and 21.3% of state matching funds. In FFY 2021, the agency received \$270,888 in federal grant funding and \$14,257 of state funds for SE services. Total SE funding from this award is \$285,145 comprised of 95% federal monies and 5% state matching funds.
